The AMA <u>Indigenous Health Committee</u> (IHC) was established to develop, implement and promote the recommendations contained in the <u>AMA Policy Statement on Indigenous Health</u>.

Dr. Cara Bablitz, Chair

Instrumental in creating the AMA Policy Statement on Indigenous Health, Dr. Bablitz was appointed chair of the Indigenous Health Committee in 2017. Dr. Bablitz is Métis from Treaty 8 territory. Dr. Bablitz's practice is based out of the Indigenous Wellness Clinic at the Royal Alexandra Hospital, where she developed the Palliative Care Outreach and Advocacy Team (PCOAT) to provide primary palliative care to patients who are vulnerable to poverty and the historical legacy of colonization and residential schools.

Pearl Auger a member of the Whitefish Lake First Nation #459 of Atikameg, Alberta which is 70 minutes north of Slave Lake. She has been involved in the health field for many years in the capacity of community health as a CHR as well as a Nursing Attendant. He has been with the AMA Indigenous Health Committee since its beginnings as a working group in 2016. He joined as a committee member in 2019 in order to support the ongoing efforts of the AMA to engage and support Indigenous communities.
